WHEREAS, the Bids and Awards Committee, NATIONAL TELECOMMUNICATIONS COMMISSION Regional Office No. 5 advertised/ posted Invitation To Bid in the NTC5 Website, PhilGeps, and in the bulletin board of this office for the above mentioned, The Procurement of Security Services for the National Telecommunications Commission Regional Office No. 5 (NCR5) under Public Bidding no. NTC-PB-2018-12-02 and NTC-PB-2019-01-01.


