MEMORANDUM CIRCULAR

NO. 07-09-97

SUBJECT: FURTHER AMENDMENTS TO THE TELECOMMUNICATIONS AND BROADCASTING AUTHORIZATION PROCESSES

In order to promote efficiency and thus be able to meet the demands of the service brought about by the on-going implementation of the National Telecommunications Development Program, the provisions of parts "E" and "F" of the NTC Practices and Procedures Manual of May 1,1992, are hereby further amended, as follows:

- Upon receipt of the NOH, the applicant shall cause publication of the same in a newspaper of general circulation and serves copies thereof with all supporting documents (including annexes) to the affected parties as indicated in the NOH, 15 days prior to the date of the initial hearing.
